## Procedural Questions ...



#### **Revocation of an entry in Register**

#### R 2002/2016-2

- Office records transfer to party A
  - Copy of signed agreement filed
- Office receives another request for transfer to party B
- Office revokes first transfer
  - First transfer invalid since not signed by administrator appointed by Court
  - EUTM assigned to party B
- Court Proceedings in Belgium between party A and party B
  - First Instance decision rendered
  - Trade mark belongs to party A
    - Assignment must be executed with immediate effect
  - Judgment not final yet



#### **Seniority Claim**

#### R 1927/2016-2

- Seniority Claim for EE trade mark
- Office accepts seniority claim (05/03/1993)
- Request to correct
  - original TM (SU) was applied for on 21/10/1983
- Request rejected
  - A priority date can only be accepted with max 6 months, but not with respect to 10 years
  - Office is not bound by national law which is in contradiction to PC



#### Description

The trade mark consists of a stylised "Y" that is positioned on both the external lateral contours of the panelling behind the vehicle cabin in the longitudinal direction of the combine harvester. [...]



#### Non traditional trade marks



The three-dimensional mark consists of a bottle closure (closure stopper or cap) with a cylindrical outer contour, a ring and a cord. The ring is placed around the neck of the bottle. The cord is fastened to the closure stopper or closure cap and led through the ring and is thus connected with the ring. [...]


