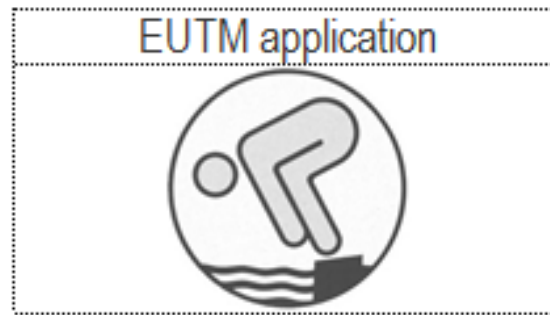

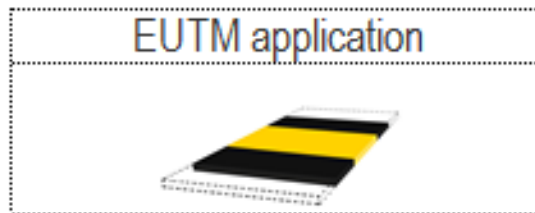

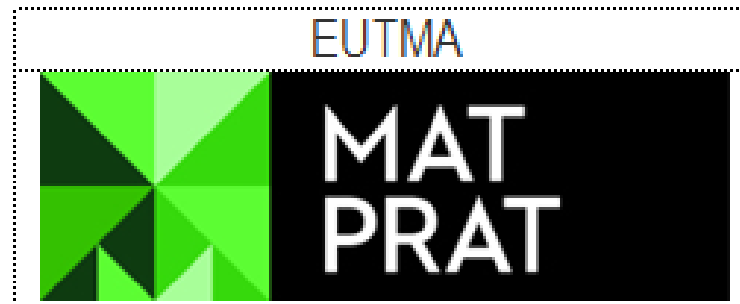

Groups or bodies representing manufacturers, producers, suppliers of services, traders or consumers which can establish an interest in the result of a case on appeal brought before the Grand Board (Article 37(6) EUTMDR) may submit written observations within two months following the information notice in the EUIPO official journal.
