

- 30/09/2016: Opposition Division conders decision against 'A'
- 29/11/2016: 'A' files Notice of Appeal
- 09/12/2016: transfer of opposing trade mark to 'B' registered
- 13/12/2016: publication of transfer in EUTM Bulletin
- 30/01/2017: Statement of Grounds filed by 'A'
