

 - Statutory provision

- Tafel
- Cl. 39, 45
 - Gathering, collection, transportation and distribution of essential goods, including foodstuffs, for others, in particular for those in need.
 - Personal and social services rendered by others to meet individual needs.

General Court

- Board used the wrong definition of the term ‘Tafel’
 - ‘a big table’ and not ‘food bank’




