**We have always worked closely with the Member States' IPOs and will continue to do so.**

By way of example, very recently, we cooperated with INPI France under the AFRIPi project and involved the DKPTO in an activity organised with the Chinese IPO (CNIPA) on trade mark applications made in bad faith.

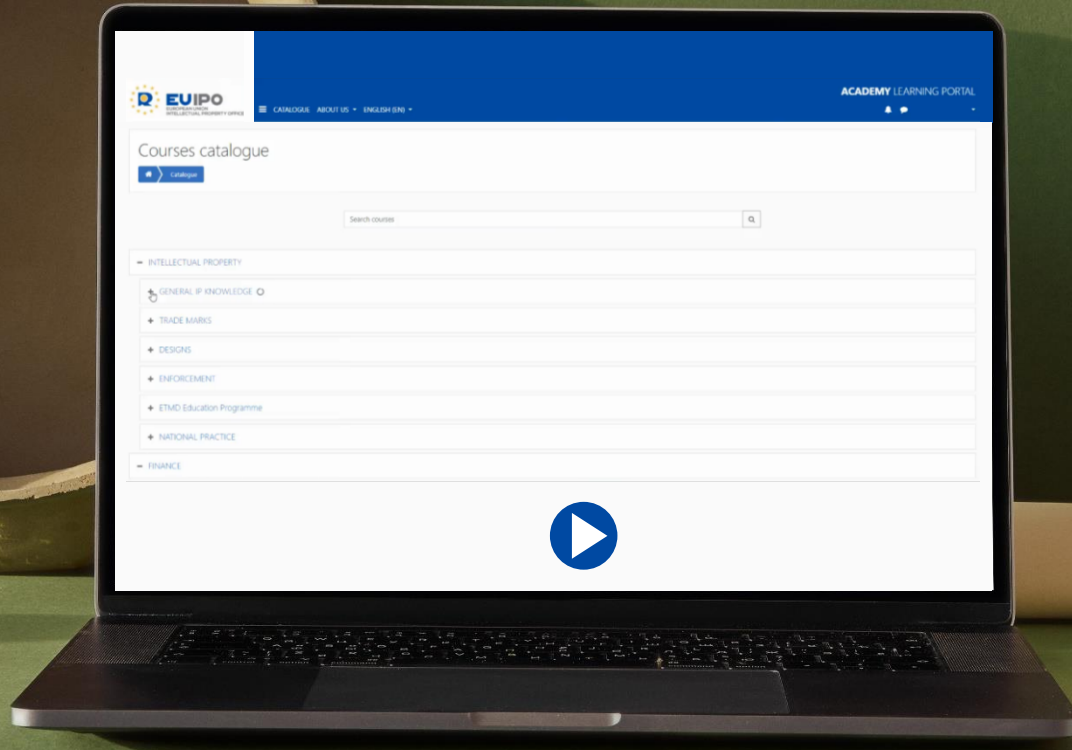
Please explain how you support countries in the areas where you are active with their IP legislative processes

**Support in IP legislative processes** can be provided **at different levels** and is always **guided by the interests of the partner country as they request it.**

This support can range from **organising policy-level workshops to raise awareness** about the benefits of international treaties on IP and how to effectively implement these, **providing legal and technical assistance** by conducting gap analyses, **drafting amendments to the law** so as to comply with EU/international standards, **preparing effective transposition and implementation** of IPR legal commitments, and **developing secondary legislation on IP rights.**
