2.1 Basic fee (Article 8(2)(i) of the Protocol)	Basic
2.1.1 Where no reproduction of the mark is in color	Basic

2.2 Supplementary fee for each class of goods and services beyond three classes, except if only Contracting Parties in respect of which individual fees (see 2.4, below) are payable are designated (Article 8(2)(ii) and (7)(a)(i) of the Protocol)	Basic
2.3 Complementary fee for each designated Contracting Party, except if the designated Contracting Party is a Contracting Party in respect of which an individual fee (see 2.4 below) is payable (Article 8(2)(iii) and (7)(a)(ii) of the Protocol)	Designation
2.4 Individual fee for each designated Contracting Party in respect of which an individual fee (rather than a complementary fee) is payable, except where the designated Contracting Party and the Contracting Party of the Office of origin are both States bound also by the Agreement, in which case, a complementary fee is payable in respect of such a designated Contracting Party (Articles 8(7)(a) and 9sexies(1)(b) of the Protocol)	Designation
5. Designation subsequent to international registration The following fees shall be payable and shall cover the period between the effective date of the designation and the expiry of the then current term of the international registration (Article 3ter(2) of the Protocol):	Subsequent designation
