

## **CORRIGENDUM**

### **TO THE CALL FOR PROPOSALS N° GR/001/21**

#### **Ideas powered for business SME FUND**

#### **Intellectual property vouchers**

Under the terms of Section 1.5 of the call for proposals GR/001/21, applications may be submitted during one of five phases (windows), that is to say January, March, May, July and September 2021.

This section also foresees that “the Office reserves the right to open an additional submissions window”.

**The Office has therefore decided to open a new window for submissions in October 2021. It will run from 01/10/2021 to 31/10/2021.**

In order to allow sufficient time for all beneficiaries to request the service(s) and submit their requests for payment, the Office has decided to extend the deadlines set out in the call for proposals GR/001/21 as follows:

- Services must be requested by the beneficiaries within 30 days of the notification of the grant decision (NO CHANGE).
- **Services must be implemented (i.e. fully completed) at the latest by 01/05/2022.**
- **Requests for payment must be submitted at the latest by 31/05/2022.**

Detailed information will be published on the [SME FUND webpage](#) to ensure that all applicants are treated equally and have access to the same information.

The adjustments to the call for proposals GR/001/21 are presented in annex to this corrigendum.

## ANNEX TO CORRIGENDUM

### TO THE CALL FOR PROPOSALS N° GR/001/21

**Applicants are informed of the following changes to the the call for proposals:**

- In Section 1.6 'Timetable', the following provision is added:

In addition to the timetable stated in the present section, a subsequent window for submissions will be opened with the following provisional timeframe:

Budget available per window	10.000.000 EUR
Start of application period	01/10/2021
<b>Deadline for submission of applications</b>	31/10/2021
Applicants receive written notification of the results and notification of grant decisions in the event of an award	November 2021

- Section 2.3 'Eligibility of the action(s)' should be read as follows:

*For:*

Action(s) will end on 31/12/2021 ('the ending date'). Service(s) must be requested and implemented at the latest by that date. Service(s) not implemented before this date will be considered ineligible.

*Read:*

Action(s) will end on **01/05/2022** ('the ending date'). Service(s) must be requested and implemented at the latest by that date. Service(s) not implemented before this date will be considered ineligible.

- Section 3.1 'Legal commitment and implementation' should be read as follows:

*For:*

Action(s) must end at the latest on 31/12/2021 as specified in section 2.3.

*Read:*

Action(s) must end at the latest on **01/05/2022** as specified in section 2.3.

- Section 3.4 'Request for payment of the balance and supporting documents' should be read as follows:

The beneficiary must submit a request for payment of the balance as soon as the service(s) has been implemented and at the latest within 30 calendar days following the end of the action (31/12/2021).

The beneficiary must submit a request for payment of the balance as soon as the service(s) has been implemented and at the latest within 30 calendar days following the end of the action (**01/05/2022**).
