**DECISION No EX-26-04 of the  
Executive Director of the Office of  
8 June 2026 on notification by  
public notice**

The Executive Director of the European Union Intellectual Property Office (the Office),

Having regard to [Regulation \(EU\) 2017/1001](#) of the European Parliament and of the Council of 14 June 2017 on the European Union trade mark (EUTMR) and in particular [Article 98\(4\)](#), and [Article 157\(4\)\(a\) and \(o\)](#) thereof,

Having regard to [Regulation \(EU\) 2026/715](#) of the European Parliament and of the Council of 11 March 2026 on European Union designs (EUDR) and in particular [Article 85\(3\)](#) and [Article 140](#) thereof,

Having regard to Commission Delegated Regulation (EU) 2018/625 of the European Parliament and of the Council of 5 March 2018 supplementing Regulation (EU) 2017/1001 on the European Union trade mark and repealing Delegated Regulation (EU) 2017/1430 (EUTMDR) and in particular [Article 59](#) thereof,

Whereas:

- (1) where notification is to be effected by public notice, pursuant to [Article 98\(4\) EUTMR](#) and [Article 85\(3\) EUDR](#), it is necessary to determine:
  - (i) how the public notice is to be given, and
  - (ii) the start of the one-month period on the expiry of which the document will be deemed to have been notified,
- (2) it is necessary to repeal Decision No EX-18-4 in view of the legislative changes to the EUDR, including terminology and legal references.

HAS ADOPTED THE FOLLOWING DECISION:

*Article 1*  
**Means of public notice**

Public notices issued in proceedings relating to European Union trade marks (EUTMs) and registered European Union designs (EUDs) will be given on the EUIPO website (<https://www.euipo.europa.eu/en/info/public-notifications>), which provides free access to public notices.

*Article 2*  
**Particulars to be contained in the public notice**

Public notices will contain the following particulars:

- a) an indication of the proceedings to which the public notice relates;
- b) the application number or registration number of the EUTM or EUD concerned, or the file number of the proceedings where applicable;
- c) the name of the addressee known to the Office;
- d) the city and country of the addressee known to the Office;
- e) the type of document to be notified;
- f) the date of the document;
- g) the place where the document can be viewed;
- h) the date on which the notice is made available on the website.

*Article 3*  
**Time limit**

The one-month time limit provided for in [Article 98\(4\) EUTMR](#) and [Article 85\(3\) EUDR](#) will start on the day on which the notice is made available on the EUIPO website, in accordance with Article 1.

*Article 4*  
**Repeal of previous decisions**

Decision No EX-18-4 of the Executive Director of the Office of 3 September 2018 concerning public notification is hereby repealed.

*Article 5*  
**Entry into force**

This Decision will enter into force on 1 July 2026 and will be published in the Official Journal of the Office.
